

Allen Institute Education Materials Library Submission Terms and Conditions

By submitting a resource ("Submission") to the Education Materials Library ("Library"), you agree to and accept the following Submission Terms and Conditions, <u>Allen Institute</u> Terms of Use, Privacy Policy, and Citation Policy (collectively, "Terms").

Submission to the Library

- You represent and warrant that you own or control all rights in and to your Submission and have the right to grant the license to it. If you include content created by others, besides Allen Institute's open science materials and/or data, you represent and warrant you have all necessary rights, including licenses or permission, to submit that content and it must be appropriately attributed and linked.
- You grant Allen Institute a non-exclusive, world-wide, royalty-free, sub-licensable, perpetual, irrevocable license in any form, media or technology now known or hereafter developed to use, store, make derivative works of, reproduce, publish, display, translate, and distribute any and all such Submission to the public for any purpose.
- You grant permission to others to use or modify the Submission and submit their modified version to the Library under these Terms.
- No fiduciary or confidential relationship or obligation of secrecy: (i) now exists between you and the Allen Institute; or (ii) is intended or established between you and the Allen Institute by your Submission or Allen Institute's receipt, review, or use of the Submission.
- Allen Institute's receipt, review, or use of the Submission is not an admission that the Submission is protected or protectable by copyright or other intellectual property law.

Your Submission must comply with all applicable laws and regulations. Submitting the following types of content is prohibited and will result in the removal of the content and/or Submission from the Library:

- Material infringing any patent, trademark, trade secret, copyright, or other intellectual property or other rights of any other person;
- Advertising, and solicitation for commercial, for-profit, or other fee-based products, events, courses, and/or professional development;
- Personally identifiable information about others, including those that reveal a person's identity;



- Material promoting any illegal activity, or advocate, promote, or assist any unlawful act;
- Materials containing spyware, computer viruses, Trojan horses, computer "worms," keystroke loggers, rootkits, or other malicious computer software;
- Material that is defamatory, obscene, indecent, abusive, offensive, harassing, violent, hateful, inflammatory, or otherwise objectionable; and
- Material promoting sexually explicit or pornographic material, violence, or discrimination based on race, sex, religion, nationality, disability, sexual orientation, or age.

You understand and acknowledge that you are responsible for any Submission and you, not the Allen Institute, have full responsibility for such content, including its legality, reliability, accuracy, and appropriateness. Allen Institute is not responsible or liable to any third party for the content or accuracy of any Submission by you or any other user of the Library.

You agree to defend, indemnify, and hold harmless the Allen Institute, and its founders, directors, officers, employees, affiliates, licensors, suppliers, successors, assigns, and agents from and against any claims, liabilities, damages, judgments, awards, losses, costs, and expenses, including reasonable attorneys' fees, arising from, or related to your Submission in violation of any of the Terms.

Submitting to the Library does *not* preclude you from using your Submission elsewhere. You may also share or publish your Submission in other venues.

Monitoring and Termination

Allen Institute has the right to:

- Remove or refuse to post any Submission for any or no reason in its sole discretion;
- Take any action with respect to any Submission that it deems necessary or appropriate in its sole discretion, including if it believes that such Submission violates the Terms, infringes any intellectual property right or other right of any person or entity, threatens the personal safety of users or the public, or could create liability for the Allen Institute;
- Disclose your identity or other information about you to any third party who claims that Submission posted by you violates their rights, including their intellectual property rights or their right to privacy; and
